IMPORTANT SAFETY INSTRUCTIONS READ AND SAVE THESE INSTRUCTIONS

💩 🛆 Fire and Electric Shock Hazard

Unit must be electrically grounded

• Insert plug on power cord directly into matching grounded receptacle.

• Do not use with an adapter.

To reduce the risk of electric shock, this plug is intended to fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reserve the plug. If it still does not fit, contact a qualified electrician. Do not attempt to defeat this safety feature.

Keep wiring and motor dry

- Never use a water hose or pressure washer to clean electrical components; water could enter the electrical compartment causing a shock hazard.
- Do not operate in standing water.
- If electrical components become wet, allow them to dry completely before using.

Unplug this appliance from the power supply before servicing

• Do not operate any fan with a damaged cord or plug. Discard fan or return to an authorized service facility for examination and/or repair.

• WARNING - Skin or eye damage may result from directly viewing the light produced by the lamp in this apparatus. Always disconnect power before relamping or servicing. Replace Lamp With Lamp PL-L TUV 18 watt 4 pin bulb.

• You may contact EnviroKlenz[®] to order replacement lamps.

WARNING:

The EnviroKlenz Air System Plus can be operated 24/7 and requires a replacement EnviroKlenz Air Cartridge every 6 months and a replacement HEPA filter every 2 years. UV Bulbs should be replaced when the exterior indicator light shows that one or both of the bulbs have burned out. Both bulbs should be replaced at the same time, even if only one has burned out. Bulbs must be disposed of as per your local law at an approved disposal station. The disposal fee has been included in the purchase price.

Appliances that are obviously damaged must not be operated.

Not suitable for use with solid-state speed controls

If unit is used in hazardous or potentially hazardous environments such as mold mitigation job sites:

- Wear protective gear when changing the HEPA filter as it may contain mold spores.
- Change The EnviroKlenz® Cartridge and HEPA filter after every remediation job.
- Dispose of used HEPA according to your local regulations.

The EnviroKlenz® Air System Plus also uses a medical-grade HEPA filter for additional particulate capture, as well as UVC lights for germicidal irradiation and interior sanitization.

INSIDE SYSTEM

1. AIR INTAKE

Air is brought in through the 3 top vented sides with 4 different speed settings to choose from.

2. ENVIROKLENZ® AIR CARTRIDGE

The EnviroKlenz® Air Cartridge uses patented natural technology to absorb and remove viruses, bacteria, VOCs and other chemicals without the use of masking agents or harmful chemicals. In most situations, this cartridge will need replacement after 6 months of use.

3. UVC LIGHTS

UVC lamps are located above (and radiating on) the collection side of the HEPA filter providing germicidal irradiation and interior sanitization of the system.

4. HEPA FILTER


The HEPA filter captures particulates larger than 0.3 microns at a 99.97% efficiency rate. In most situations, the HEPA filter will need replacement after 2 years of use.

5. CLEAN AIR OUTTAKE


Filtered, clean air is directed out into the environment from the bottom vent. On average, the air will be exchanged 3-5 times per hour on the highest setting depending on the size of the room.

NOTE: Be sure to follow your country's electrical regulations.







SET-UP & ACCESSORY REPLACEMENT



STEP 3: Install the **UVC light bulbs** by carefully pushing them into the light sockets inside the Air System. * Avoid touching the glass portion of the bulbs directly with your hands, as it may shorten the lifetime of the UVC bulbs.






STEP 4: Slide in smaller EnviroKlenz® Air Cartridge above the UVC lights on the rails with airflow arrow facing down.

STEP 5: Slide down back panel by pulling on the safety knob. Make sure the bottom ledge is facing the inside of the unit. Plug electrical cord into a grounded outlet





STEP 6: Turn on the UVC Lights

STEP 7: Turn power control knob to desired fan speed and begin enjoying clean, allergen and chemical free air

BEST PRACTICES


DO'S

• • • • • • • • • • • • • • • •

- To acclimate the system to your environment, please run the system on the whisp-air or low speed setting for the first 24-48 hours.
- Set up the air system in an area where it will provide good air circulation, but won't get in the way.
- To help maneuver air in the space, you may want to set up a few fans in areas that are somewhat distant from the air unit(s). Have the fan(s) push/blow the air towards the air unit(s). This will help exchange the air so that it quickly gets processed through the system.
- Leaving a system running 24/7 will help clear the air faster.
- Since the unit is relatively quiet, it can be run on medium or high setting without disturbing normal activities.
- The EnviroKlenz® Air Cartridge operates best when it is aligned with the rail entrance.
- When changing the UVC bulbs
 - Use protective equipment
 - Only touch the lamps by the plastic sockets
 - To avoid the potential for glass to enter the blower, the HEPA filter must be installed or, if not possible, the finger protection grille must be covered.


DON'TS

- Do not place the air unit directly against a wall, as you want to ensure airflow.
- Do not use with an ozone-producing machine because it can reduce the efficacy of the EnviroKlenz Air System and limit the lifetime of the filters.



• The Power Indicator Light (1) should illuminate when power is flowing to the system. If it is not illuminated, check the power connection and ensure that the back panel is closed securely.

• When the UVC lights are turned on, the indicator lights (2) should be on and green. If the UVC light switch (4) is on, but the indicator light(s) are off, the UVC bulb(s) need to be replaced.



WHISP-AIR

• • • • • • • • • • • • • • • • • •

Great for situations that require minimal noise such as sleeping and watching TV. This setting should be used for at least the first 24-48 hours of running.

LOW

.

Ideal for everyday maintenance use when a contaminate source is not overly present or noticeable.

MEDIUM

.

Ideal for most situations in which a contaminate source is noticeable but not overbearing, such as cooking odors or outdoor pesticide use.

HIGH

.

Setting ideal for environments with high levels of physical particulate matter. This includes heavy renovation, construction, fire damage, and flood damage.

TROUBLESHOOTING

ISSUE	ACTION
"Air System will not turn on"	 Make sure Air System Plus is plugged in. Make sure the back panel is in place. Check power at the outlet. Test the on/off switch.
"The blower wheel is not turning"	Check for obstruction(s).Tighten set screw.
"The System blower has started to get louder"	• It may be time to change your filters.
"UV indicator light(s) is (are) off"	 Verify the UV feature is turned on UV Bulb may be burnt out or not properly installed
"The HEPA filter is difficult to remove"	 Make sure the thumbscrews holding the HEPA in place have been loosened. Apply force in an upward direction on the HEPA to loosen it from the seal with the blower cage.

• UVC Lights or germicidal UV are at a much more specific wavelength than what is termed "UV" broadly, which encompasses the wavelengths of 100-380 nm. UVC are low-pressure lamps, more like a fluorescent lamp, with a specific wavelength of 253.7 nm (1182.5 THz).

• To create ozone from UV, the light wavelength would need to be in the range from 160-240 nm.

- Since the EnviroKlenz Air System Plus uses UVC with a wavelength of 254 nm, it is outside of the ozone-producing range.
- You can run the system without the lights being on, but you will not get the benefits of the UVC lights.

 Unintended use of the appliance or damage to the housing may result in the escape of dangerous UV-C radiation. UV-C radiation may, even in little doses, cause harm to the eves and skin.


